

# China Consular Processing Information



## U.S. Passport Holders:

- o Passports must be valid for at least 18 months or more. The consulate reserves the right to deny visas to passports that are valid for less than 18 months.

## U.S. and Non-U.S. Passport Holders:

- o Passports must have at least 2 blank "visa" pages. Endorsement pages in the back do not count.
- o Passports must be signed – visas will not be issued to unsigned passports.

---

## Visa Requirements

### 1. Valid and Signed Passport

- Unsigned passports will be returned to the traveler, thus will delay visa processing.
- U.S. Passports must be valid for at least 18 months or more. Non-US. Passports must be valid for at least 6 months.

### 2. One (1) Passport Quality Photo

- **Cannot be the same photo as in passport**
- Photo must be taken against a **pure WHITE background**. Photos displaying non-white background are subject to consular scrutiny.
- The applicant is required to present a frontal view to the camera with the entire head and face clearly visible
- No harsh shadows on face. Facial features must be clearly visible.
- Must have been taken within the last 6 months
- Must be printed on photo paper. Standard printer paper is not acceptable.
- Must be a high quality photo. Photos that are too pixilated or blurry will not be accepted

### 3. Copy of your airline ticket, travel agent itinerary, or e-ticket confirmation

- Traveler's name must be listed

### 4. Copy of Hotel Confirmation **OR** Letter of Invitation from Inviter in China + Inviter's resident ID/Visa (*Tourist Visa Applicants only*)

- Traveler's full name must be listed
- If providing a letter of invitation, letter must include the following.
  - o Addressed to the "Consulate of The People's Republic of China"
  - o Host's complete name
  - o Host's address in China
  - o Host's phone number
  - o Confirmation that traveler will be residing with the host
  - o Financial Guarantee
  - o Letter must be signed by host

### 5. Completed China Visa Application Form

- Application form must be typed. Handwritten forms are not acceptable.
- If you are unable to type your form VP2Go can re-type it for an additional \$15.00. Please complete the form by hand and submit with the rest of the listed materials.

## Consular Processing Information

    - If your previous Chinese visa is in another or expired passport please also send that passport

9. **Conference Non-Business (F-Type) Visa Applicants:** Letter of Invitation from the organization in China.
- Travelers visiting China for workshops, conferences, lectures, symposiums, seminars conventions, and anything of similar nature, will be issued a Non-Business visa.

10. **Business Visa (M-Type) Applicants:** Letter of Invitation from inviting organization in China
11. **Business Visa (M-Type) Applicants:** Letter of Guarantee from your company/employer in the United States.

### **Requirements for Invitation and US Company Letters**

- Must be on company letterhead
  - Both letters must be addressed to "Consulate of The People's Republic of China"
  - Traveler's full name must be included. Missing middle names may result in rejection of visa request.
  - Purpose of travel: "To attend business meetings and discussions only"
  - Contact person in China and their contact information
  - Financial Guarantee
  - Can be signed by any official within the company, except the traveler.

12. **Student Visas:** In addition to relevant items above, please also send the following:
- Official letter of acceptance/enrollment from the university in China
- 

13. **Minors** (17 years old or younger): In addition to relevant items above, please also send the following.
- If the applicant is younger than 18 years old the application must be signed by a parent and/or guardian.
  - Letter of consent addressed to "The Consulate of The People's Republic of China". Letter must be signed by both parents.
  - If either parent is currently a Chinese national they must provide a colored copy of their valid U.S. Green card or U.S. Visa.
  - Copy of both parent's passport photo page
  - Copy of both parent's valid driver's licenses
  - Colored copy of minor's birth certificate.
  - IF biological parents are not the legal guardians please provide copy of official court order or legal document stating who the minor's legal guardians are.
  - **Additional information may be requested by the consulate in addition to what is listed above**
